THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN VARIOUS ROADS IN HEYDON, GREAT CHISHILL, BARLEY, BARKWAY, BUCKLAND, CHIPPING, BUNTINGFORD, HARE STREET, GREAT HORMEAD AND BRENT PELHAM DURING THE 'RIDE LONDON CYCLING EVENT') ORDER 2024

NOTICE is given that the Hertfordshire County Council intend to make an Order under Section 16[A] of the Road Traffic Regulation Act 1984, to prohibit all traffic from using the following lengths of roads, and to prohibit all vehicles from waiting at any time on both sides of these lengths of roads for the duration of the event:-

1. that length of Chishill Road, Heydon/Heydon Road, Great Chishill from its junction with Heydon Lane south westwards to its junction with B1039 Barley Road, a distance of approximately 1640 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

2. that length of B1039 Barley Road, Great Chishill from its junction with Heydon Road north westwards and south westwards to its junction with B1039 Chishill Road, a distance of approximately 1531 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

 that length of B1039 Chishill Road, Barley from its junction with B1039 Barley Road south westwards to its junction with Church End, a distance of approximately 508 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

 that length of Church End, Barley from its junction with B1039 Chishill Road south westwards to its junction with B1368 London Road, a distance of approximately 431 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

 that length of B1368 London Road, Barley from its junction with Church End south westwards to its junction with B1368 Cambridge Road, a distance of approximately 518 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

 that length of B1368 Cambridge Road, Barkway/Barley from its junction with B1368 London Road south westwards to its junction with B1368 High Street, a distance of approximately 2588 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

7. that length of B1368 High Street, Barkway from its junction with B1368 Cambridge Road south westwards and southwards to its junction with B1368 London Road, a distance of approximately 985 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

8. that length of Buckland Road, Barkway/C10 (unnamed road), Buckland from its junction with B1368 High Street south westwards to its junction with A10 Ermine Street, a distance of approximately 3061 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

 that length of A10 Ermine Street, Buckland/A10 (unnamed road), Chipping/A10 Buntingford Bypass, Buntingford from its junction with C10 (unnamed road) southwards, south westwards and south eastwards to its junction with the A507 Baldock Road/B1038 Baldock Road roundabout, a distance of approximately 4567 metres.

An alternative route will be via A10 (London Road/Market Hill/Priory Lane/Melbourn Road), A505 (Royston Bypass/Baldock Road/Royston Road/Baldock Bypass), A1(M), A602 (Broadhall Way/Hooks Cross/Watton at Stone Bypass/Ware Road/Tonwell Bypass/Westmill Road) and A10 (unnamed road)/Wadesmill Bypass/Puckeridge Bypass/(unnamed road)/Buntingford Bypass)

or via A10 (Buntingford Bypass/(unnamed road)/Puckeridge Bypass/Wadesmill Bypass/(unnamed road), A602 (Westmill Road/Tonwell Bypass/Ware Road/Watton at Stone Bypass/Hooks Cross/Broadhall Way), A1(M), A505 (Baldock Bypass/Royston Road/Baldock Road/Royston Bypass) and A10 (Melbourn Road/Priory Lane/Barkway Street/London Road)

or via A10 (London Road/Market Hill/Priory Lane/Melbourn Road), A505 (Royston Bypass/Baldock Road/Royston Road/Baldock Bypass), B197 (Jacks Hill/High Street/Graveley Road), A602 Hitchin Road, A1072 Gunnells Wood Road, A602 (Broadhall Way/ Hooks Cross/Watton at Stone Bypass/Ware Road/Tonwell Bypass/Westmill Road) and A10 (unnamed road)/Wadesmill Bypass/Puckeridge Bypass/(unnamed road)/Buntingford Bypass)

or via A10 (Buntingford Bypass/(unnamed road)/Puckeridge Bypass/Wadesmill Bypass/(unnamed road), A602 (Westmill Road/Tonwell Bypass/Ware Road/Watton at

Stone Bypass/Hooks Cross/Broadhall Way), A1072 Gunnells Wood Road, A602 Hitchin Road, B197 (Gravely Road/High Street/Jacks Hill), A505 (Baldock Bypass/Royston Road/Baldock Road/Royston Bypass) and A10 (Melbourn Road/Priory Lane/Barkway Street/A10 London Road).

10. that length of B1038 (Baldock Road/High Street), Buntingford from its junction with the A507 Baldock Road/A10 Buntingford Bypass roundabout north eastwards, south eastwards, north eastwards and south eastwards to its junction with B1038 Hare Street Road, a distance of approximately 900 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

11. that length of B1038 Hare Street Road, Buntingford/B1038 (unnamed road), Hare Street from its junction with B1038 High Street north eastwards, south eastwards, south westwards, southwards, south eastwards and north eastwards to its junction with B1368 (unnamed road), a distance of approximately 2873 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

12. that length of B1368 (unnamed road), Hare Street from its junction with B1038 (unnamed road) northwards to its junction with B1038 (unnamed road), a distance of approximately 45 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

13. that length of B1038 (unnamed road), Buntingford/B1038 Conduit Lane, Great Hormead, Brent Pelham from its junction with B1368 (unnamed road) north eastwards, south eastwards and north eastwards to its junction with B1038 Pump Hill, a distance of approximately 4664 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

14. that length of B1038 Pump Hill, Brent Pelham from its junction with B1038 Conduit Lane south eastwards, north eastwards and south eastwards for a distance of approximately 2408 metres.

There is no alternative route available for vehicles whilst the event takes place. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the event.

The temporary road closures and the temporary waiting restrictions will be in place between the hours of 11.00am and 12.30pm on Friday 24 May 2024, when signs are in place.

The purpose of the Order is to ensure public safety and prevent accidents for the duration of the 'Ride London Cycling Event'.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
